I have a few announcements to share about some ADI staff retirements, oral argument status in the three Divisions, and some resources to help navigate the new laws.

ADI Staff Changes

Oral Argument in Divisions 1, 2 and 3

Division 1 will be transitioning back to in-person oral argument effective March 2022. The court prefers in-person argument, but counsel may opt to appear remotely without a showing of good cause until further notice. Additional details can be found on the <u>Court of Appeal website</u>.

Division 2 will be conducting oral argument remotely until further notice.

Division 3 has returned to in-person oral argument. The court has a strong preference for in-person oral argument.

Navigating the New Laws

Last week, the Court of Appeal, Second Appellate District, Division Five issued *People v. Williams* (B311161) [2022 WL 556906]. The opinion followed a *People v. Serrano* (2012) 211 Cal.App.4th 496 brief and focuses on duty of candor to the court. These can be difficult situations for all of us.
