PC 1001.15	Administrative fee, as part of an enrollment fee in a deferred entry of judgment diversion program, for felony convictions (section repealed)
PC 1001.16	Administrative fee, as part of an enrollment fee in a deferred entry of judgment or diversion program, for misdemeanor convictions (section repealed)
PC 1001.90	Collection fee for diversion restitution fee (former subd. (g))
PC 1202.4	Collection fee for restitution fine (former subd. (l))
PC 1203.1	Collection for victim restitution (former subd. (l))
PC 1203.1ab	Cost of drug testing (deleted from subd. (a))
PC 1203.1c	Cost of incarceration when sentence includes local confinement as a term of probation or conditional sentence (section repealed by operation of law)
PC 1203.1m	Cost of imprisonment (section repealed by operation of law)
PC 1203.4a	Reimbursement of costs of services associated with misdemeanor or infraction, upon dismissal of case (former subd. (e)). NOTE: bill also makes changes to protective orders (new subd. (c)(4))
PC 1203.9	Local fees associated with receiving jurisdiction when probation or mandatory supervision case is transferred (former subd. (d)(3)); receiving court cannot impose additional local fees and costs (subd. (d)(2))
PC 1205	Installment account processing fee (former subd. (e))

PC 1214.5	Interest on restitution as a condition of probation (repealed by operation of law)
PC 1463.07	Administrative screening fee, citation processing fee (repealed)
PC 1465.9	Balance of various court-imposed costs is unenforceable and uncollectible and any portion of judgment imposing these costs shall be vacated (PC 1001.15, 1001.16, 1001.90, 1202.4, 1203.1, 1203.1ab, 1203.1c, 1203.1m, 1203.4a, 1203.9, 1205, 1214.5, 2085.5, 2085.6, or 2085.7)
PC 2085.5	Administrative fee to cover cost of collection of restitution fine or restitution order (former subs. (e) [prison inmates], (f) [jail inmates], (i) [parolees])
PC 2085.6	Administrative cost of collecting restitution fine and restitution order from those on PRCS or mandatory supervision (former subd. (d))
PC 2085.7	Administrative cost of collecting restitution fine and restitution order from those completing term of custody (former subd. (d))
VC 40508.5	Assessment for every person who violates promise to appear or otherwise fails to comply with valid court order (repealed)
VC 40510.5	Fee for processing installment accounts for payment and forfeiture of bail for infraction violations (former subd. (g))
VC 42240 (newly enacted)	Unpaid balance of court-imposed costs pursuant to VC 40508.5 and 40510.5, subd. (g), shall be unenforceable and uncollectible and any portion of judgment imposing those costs shall be vacated
