SB483 Appeals - Update

The California Supreme Court has granted review in *People v. Rhodius* (2023) 97 Cal.App.5th 38, review granted Feb. 21, 2024, S283169, to address the following issue as summarized in the court’s News Release: “Does Senate Bill No. 483 (Stats. 2021, ch. 728) entitle a defendant to a full resentencing hearing under Penal Code section 1172.75 if the defendant’s prior prison term enhancements (Pen. Code, sec. 667.5, subd. (b)) were imposed and stayed rather than imposed and executed?” The opinion remains published while the court considers the merits of the case. Note that review has also been granted and held under this lead *Rhodius* case, in *People v. Christianson* (2023) 98 Cal.App.5th 300, review granted Feb. 21, 2024, S283189.

San Bernardino Superior Court Records

A panel attorney contacted the San Bernardino Superior Court and shared this information for the newsletter: If you receive one volume of an RT in a case with multiple volumes, it may be that all volumes were bound together. If the aggregate RT is 300 pages or less, the superior court may bind it into one volume to make it easier for everyone. The superior court also indicated that on 1172.6 cases, they prefer a motion to augment rather than a record omission letter when requesting jury instructions and verdicts from the prior trial. In the superior court’s view, the material is not part of the normal record.
