# October 2025 News Alert

## **Pending Legislation**

October 12, 2025 is the last day for the Governor to sign or veto bills passed by the Legislature before September 12th and in the Governor's possession on or after September 12th. (Cal. Const., art. IV, § 10, subd. (b)(1).) Bills signed within this time period will take effect on January 1, 2026. (Cal. Const., art. IV, § 8, subd. (c).)

Several bills may be helpful to watch, including:

- 1. Additional revision to the Racial Justice Act in <u>Assembly Bill No. 1071</u> and <u>Senate Bill No. 734</u>.
- 2. Revision of post-conviction discovery under Penal Code section 1054.9 in <u>Assembly Bill No. 1036</u>
- 3. Reduction in permissible length of probation term for most minors in Assembly Bill No. 1376,
- 4. Amendment to CARE court procedure in Senate Bill No. 27
- 5. Amendment to stalking in Penal Code section 646.9 in <u>Senate Bill No.</u> 221
- 6. Expansion of circumstances under which sexual intercourse of spouse constitutes rape within the meaning of Penal Code section 261 in Senate Bill No. 258
- 7. Amendment of immigration advice to be given at time of guilty plea in Penal Code section 1016.5 in <u>Senate Bill No. 281</u>
- 8. Codification of principle that purpose of criminal sentencing is to reduce recidivism, encourage normalization and dynamic security in CDCR in Senate Bill No. 551
- Slight expansion of Penal Code section 290 registration in <u>Senate Bill</u> <u>No. 680</u>

Note that the Governor has already signed <u>Senate Bill No. 627</u>, which provides local and federal law enforcement agencies operating in California shall not wear facial coverings. Assistant Homeland Security Secretary Tricia

McLaughlin has issued a <u>press release on 09/22/2025</u> stating the agency will not follow the new law.
